Upon review, staff certifies that the above action conforms to the requirements of the City's Codified Zoning Ordinances, specifically Chapter 1324, but only with the following conditions being satisfied in conjunction with the proposed use(s) or development:

1. **Environmental Assessment (SEQR):** The Department of Planning hereby accepts and adopts the findings of the SEQRA review, finalized and dated February 7, 2024.
2. **Site Plan:** This approval is granted based upon the Site Plans provided to the Department of Planning titled "56th Street Transfer, LLC Transfer Station" prepared by Ensol Inc., dated February 2024, received by the Department of Planning on February 7, 2024. Substantial deviation from this plan shall render this approval null and void.
3. **Compliance:** Comply with all applicable State and local building, safety, and health codes. Deviation from or non-compliance with any conditions of this Site Plan approval shall render this approval null and void.
4. **Expiry Date:** Applicant shall act to implement and substantially complete the proposed action, as approved, within 18 months from the date of approval. Failure to substantially complete the proposed action shall render this Site Plan Approval null and void unless an extension is granted.
5. **Other Approvals:** The applicant shall obtain all necessary approvals and permits from the NYSDEC and any other applicable approving agencies and comply with all conditions associated therewith. Any modification of site operations shall necessitate notification of the Niagara Falls Planning Board. Failure to comply with Planning Board and other regulatory agency conditions shall render this approval null and void.
6. **Lighting:** All exterior site lighting, including wall packs, shall be angled downward only and away from adjacent properties. All fixtures and luminaries shall be of a full cut design and shall be of a type that does not exceed a 90° cutoff angle. Any light standard shall not exceed 25' in height.



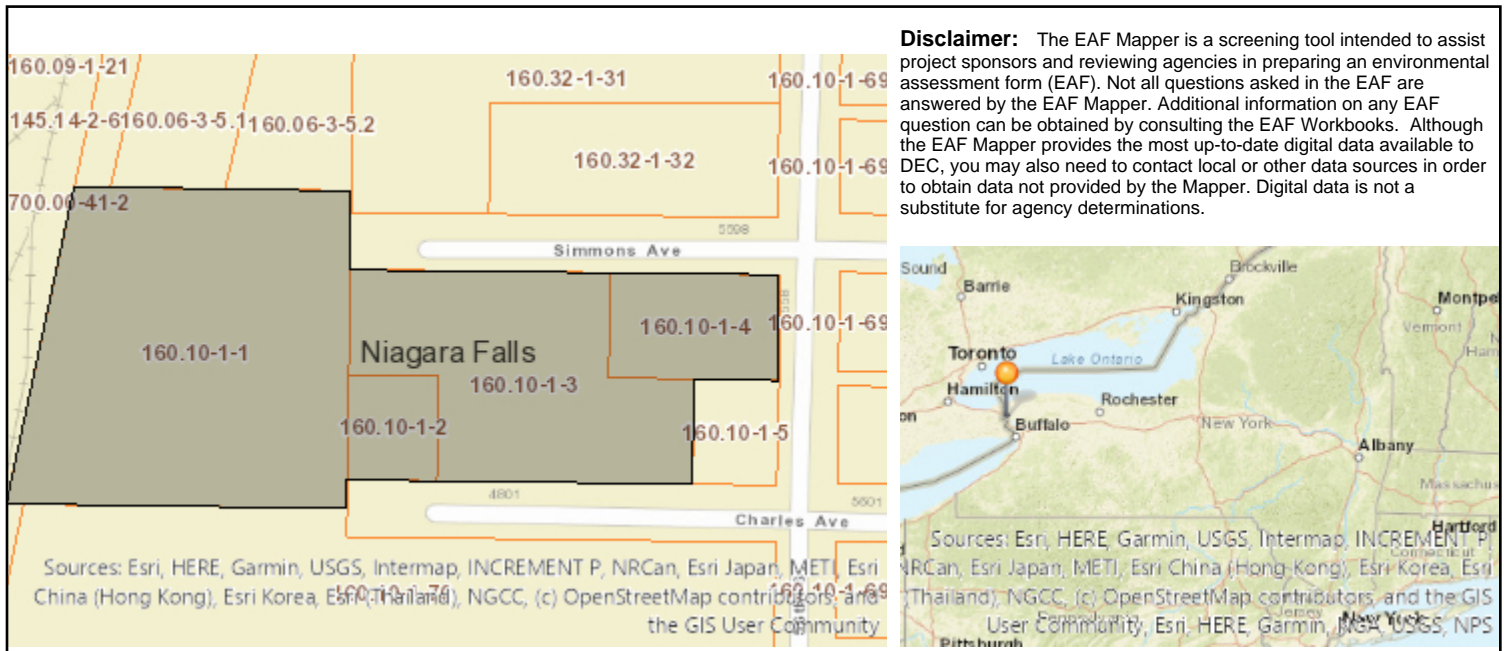

The following memo has been drafted to support the findings that the construction and operation of the 56th Street Solid Waste Transfer Facility in the City of Niagara Falls will not have any significant adverse environmental impacts.

February 7, 2024

Name of Project: Solid Waste Transfer Facility for Consolidation and Transfer municipal solid waste (MSW), construction & demolition debris (CDD), and single stream recyclables (SSR)

SEQR Status: Type I

Determination of Significance: Negative Declaration

A thorough analysis of the environmental record and potential environmental impacts associated with the project reveals that the plan will not have any significant environmental impacts. Therefore, it is applicable that the agency issues a negative declaration pursuant to SEQR for the proposed project.

Section 1. Project Overview

The applicant has proposed the construction and operation of an approximately 16,000 square foot solid waste transfer station building for the consolidation and transfer of MSW, C&DD and SSR. Located at 540 56th Street, the project site is in the City's I2 Industrial District.

Section 2. Supporting Statements

Based upon the agency's review of the environmental report and the investigation of possible adverse environmental impacts associated with the project, the agency has deemed that the project will not have any known adverse environmental impacts. The supporting reasons for this statement are as follows:

1. Impact on Land:

The current site consists of an overgrown gravel surface and is largely vacant and underutilized. The property located in an I2 Industrial zoning district. Per the City's zoning code, "waste related" uses are a permitted use; thus, a Special Use Permit is not required.

The proposed project will result in 4.17 acres of impervious surface, creating stormwater runoff from a new point source. The applicant constructed a stormwater

system plan in accordance with Niagara Falls Engineering Department recommendations and guidance.

2. Impact on Geologic Features:

The project site does not have any unique geologic features present.

3. Impacts on Surface Water:

The proposed project site is not within notable distance to any existing wetlands, waterbodies, shorelines, beaches, or adjacent areas.

4. Impact on Groundwater:

The proposed action will create a new water demand of about 150 gallons/day. The existing public water supply (Niagara Falls Water Board) has capacity to serve the facility, and a private connection will be constructed. The project will also generate about 150 gallons/day of liquid waste. The sanitary wastewater will be discharged to a combined sewer. Tipping floor washwater drainage will be discharged to the sewer via an oil/water separator. The facility will use the existent Niagara Falls Wastewater Treatment Plant, as it has the capacity to serve the project.

5. Impact on Flooding:

The proposed project will not result in development on lands subject to flooding.

6. Impact on Air:

The facility will use machinery and generators as needed during construction that will result in air emissions. Construction is estimated to be about six months; thus, this is not a long-term source of pollution. During operation, they will have daily truck traffic for incoming and outgoing loads. There will be no emissions created that would require State or Federal Permits. A traffic analysis was completed, and there will be approximately 260 trips made per day once operations commence. This is expected to be the future, long-term average. Emissions from these incoming and outgoing facility trucks do not pose a significant negative impact on air quality.

7. Impact on Plants and Animals:

The proposed project will not result in a significant loss of flora or fauna, as the site currently consists of an overgrown gravel surface and is largely vacant. There are no predominate wildlife species or designated significant natural communities that occupy the site.

8. Impact on Agricultural Resources:

The project site and surrounding property is not located in a designated agricultural district certified pursuant to Agricultural and Markets Law.

9. Impact on Aesthetic Resources:

The land use of the proposed action is similar to the current land use patterns. The immediate vicinity of the project is industrial and commercial.

10. Impact on Historic and Archeological Resources:

The project site is not in or adjacent to a historic or archeological resource.

11. Impact on Open Space and Recreation:

The project site and its adjacent properties are not presently used by members of the community for public recreation.

12. Impact on Critical Environmental Areas:

The project site is not located in, nor does it adjoin a state listed Critical Environmental Area.

13. Impact on Transportation:

Per the traffic Impact Evaluation, and based on the information available from NYSDOT, it has been determined that there will be increases of total traffic on the proposed routes ranging from 0.57% (Niagara Falls Boulevard) to 5.72% (56th Street from the Facility to Buffalo Avenue). The estimated traffic is 260 trips per day while in operation for the foreseeable future.

The projected traffic will not increase the capacity of the existing network, nor will it have a large impact on degrading existing transit. Traffic to and from the facility will not alter the present pattern of movement of people or goods in a significant way or generate substantial new demand for transportation facilities or services.

14. Impact on Energy:

The estimated annual electricity demand during operation of the proposed action is no more than 400 amp. 480 volts via local grid. It will not require any modification to the existing substation.

The estimated electricity demand for the proposed site is not considered significant.

15. Impact on Noise, Odor, and Light:

The proposed action may result in routine odors for more than one hour per day. Odors will be present in the building based upon the nature of the materials being transferred;

however, operational procedures, as required by the facility's NYSDEC Solid Waste permit will ensure minimization of odor. The applicant established the procedures in their Facility Manual which includes cleaning indoor material handling areas on a regular basis, odor neutralizers and deodorizers (i.e. Barrel misters) for short term issues, keeping facility doors shut, and an air purification system if odor issues persist.

Exhaust odors from heavy equipment and trucks will be minimized by limiting idling engines in accordance with current regulatory idling restriction. Burning of materials will not be permitted in the facility.

The above mitigating procedures are expected to keep odors low, so as to not create a significant adverse impact.

16. Impact on Human health:

The NYSDEC have previously 'closed' an onsite spill at the projects proposed location. This typically suggests that the spill incident has been remediated to the satisfaction of the NYSDEC.

There are also several closed spill incidents within a .5-mile radius of the site that did not occur onsite or at adjoining properties. Due to the status of these spills, the agency does not believe that they would knowingly have a significant adverse impact.

A Phase II subsurface investigation was performed in 2018 at the site. Five soil samples from 13 test pits were analyzed. There was one detection of Mercury, as well as one detection of PCB above NYSDEC Commercial Use Soil Cleanup Objectives (SCOs). All remaining results from the soil samples were either non-detect or below applicable SCOs. The Mercury hit of 3.8ppm was above the SCO of 2.8, but well below the Industrial SCO of 5.7ppm. Similarly, the PCB hit of 5,110ppm was above the Commercial SCO of 1,000, but well below the Industrial SCO of 25,000. The proposed property use better fits DEC's definition of Industrial rather than Commercial. Considering the intended use of the facility, along with the City zoning code, the mentioned analytical data regarding Mercury and PCB levels, meets the applicable SCOs (Industrial), and therefore does not pose a significant environmental risk.

The project site was formally Erie Niagara Recycling, and the proposed project will be within the boundary of the previous facility. Per Phase 1 ESA (2017) recommendations, the applicant will monitor fill materials during construction for possible nuisance characteristics by establishing a Materials Management Plan that will outline assessment and handling procedures for all fill and soil materials that will be exposed/generated during construction. All materials will be assessed by a Qualified Environmental Professional, and procedures for appropriate segregation, secondary analytical testing, and off-site disposal will be in place.

Due to the nature of the project, there is an obvious concern for human health, however, the proposed solid waste facility has developed a waste control plan in accordance with the NYSDEC Solid Waste permit to ensure acceptance of only authorized material into the facility. The program consists of monitoring incoming wastes destined for disposal, staff training, and a planned response when unauthorized waste is delivered to the facility.

The facility is more than 600' away from the nearest occupied structure and is not within 1500 feet of facilities with children, elders, or folks with disabilities.

Due to the explanations above, the project would not have a significant impact on the health and safety of facility personnel or the general public.

Section 3. Since the project will not have a significant adverse impact on the environment, a negative declaration pursuant to SEQRA is hereby released. This negative declaration has been prepared pursuant to and in agreement with the requirements of SEQRA.
